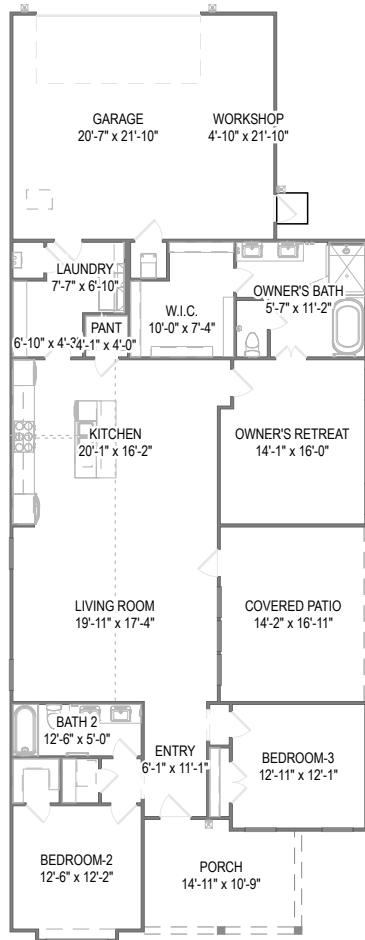

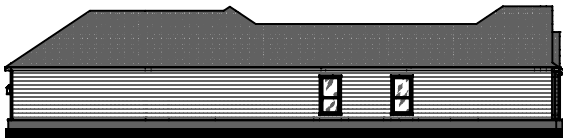




Front Elevation
